1. Quotations are invited in duplicate for the various items shown below / overleaf / **Enclosed list**.
2. **The Quotations duly sealed and superscribed on the envelope with the reference No. and due date, should be addressed to the undersigned and contain in 2 bid system i.e. Technical bid and Commercial bid in two separate envelopes should be enclosed in a single envelope only so as to reach on or before the due date stipulated above.**
3. The Quotations should be valid for ninety days from the due date and the period of delivery required should also be clearly indicated.
4. If the item is under DGS&D Rate contract No. and the price must be mentioned. It may also please be indicated whether the supply can be made direct to us at the Rate contract price (Please note that we are not Direct Demanding Officers). If so please send copy of the RC.
5. Relevant literature pertaining to the items quoted with full specifications (and drawing, if any) should be sent along with the Quotations, wherever applicable. Samples if called for, should be submitted free of charges, and collected back at the supplier's expenses.
6. Local Firms : Quotations should be for free delivery to this Institute. If Quotations for Ex-Godown delivery charges should be indicated separately.
7. Firms Outside Madras : Quotations should be for F.O.R. Madras. If F.O.R. consignor station, freight charges by passenger train / lorry transport must be indicated. If Ex-Godown, packing, forwarding and freight charges must be indicated.
8. The rates of GST and other taxes legally leviable and intended to be claimed should be distinctly shown along with the price quoted. Where this is not done, no claim for GST/General Taxes will be admitted at any stage and on any ground whatsoever. IIT Madras is eligible for concessional GST. Relevant certificate will be issued. In case of import supply the price should be quoted without custom duty. IIT Madras is exempted from levy of IGST on Imports and eligible for concessional custom duty (not exceeding 5%) and the price should be quoted on **EX-WORKS** and **CIP** basis indicating the mode of shipment.
9. Goods should be supplied carriage paid and insured.
10. Goods shall not be supplied without an official supply order.
11. Payment: Every attempt will be made to make payment within 30 days from the date of receipt of bill / acceptance of goods, whichever is later.

## Technical Specifications for Cooling Incubators

The following are the required features:

1. Temperature range: 4 °C to 100 °C
2. Electric cooling with Peltier module
3. Controller with time-segment and real-time programming
4. Display via LCD monitor
5. Inner door with tempered safety glass
6. Minimum 2 stainless steel racks (stackable)
7. Class 3.1 independent temperature safety device with visual and audible temperature alarm
8. Computer interface: Ethernet Data recording and USB interface
9. Temperature uniformity at 4 and 37 °C [ $\pm$  K] : 0.3
10. Temperature uniformity at 25 °C [ $\pm$  K] : 0.1
11. Temperature fluctuation [ $\pm$  K] : 0.1
12. A net width of 860mm, net height of 715 mm and net depth of 655mm with an internal volume of 102 L
