Option should be available to increase the number of calls (ports) up to 40 under Full HD (1080p30fps) resolution at a later stage with no additional hardware but only a software upgrade. These calls (ports) should also be able to support equivalent SD ports based on their resolution. It should be possible to run **15 simultaneous meetings (concurrent conferences)** using these 30 ports at 1080p 30fps (if upgraded 40 ports) in any combination. For example @1080p (as per current requirement):

- Eg 1: 10 calls in conf 1 and 10 calls in conf 2 and 10 calls in conf 3 simultaneously
Eg 2: 5 simultaneous conferences each with 6 calls
