## Terms and Conditions:

- a) Premium should be quoted inclusive of all taxes, if any.
- b) Quotation should be valid for a period of 90 days from the Last date for submission of quotation.

- d) Documents to be produced for claim settlement are to be listed.

- g) No increase in premium during the policy period will be entertained.
- h) Normal retirement age is 62 for Registrar / Scientific and Design Officers / Librarian, 65 for faculty members and 60 for others.
- i) For Faculty members, who have completed the age of 65 during the policy period the Insurance coverage should be till the end of Academic year (i.e. upto 30th June).

The sealed quotations are to be submitted either in person or by ordinary post only on or before the due date. Late quotations/quotations received after the due date will be summarily rejected.
