SECTION - II

COMMERCIAL AND TECHNICAL CONDITIONS

2.1 GENERAL

The scope of services shall be as detailed in Section - III of this specification.

2.2 LOCATION

The site is located in the Kamarajar Port, Ennore, Chennai.

2.3 COMPLETENESS OF TENDER

The tender should be complete in all aspects. The tenderer shall furnish all relevant details called for in the specification with supporting documents wherever required for considerations by IC & SR. The tenders not containing the complete details as requested in the specification are liable for rejection.

2.4 PRICES

Tenderers shall quote FIRM Price only. Shall quote price separately for each item in the respective schedule as prescribed in the specification

2.5 VALIDITY OF TENDERS

Tenders should be valid for acceptance for a period of at least (30) Thirty days from the date of tender opening. In case any bidder quotes a lower validity period than that called for, his offer shall be liable for rejection. In exceptional circumstances, the purchaser may solicit the bidder's consent to an extension of the period of the validity. 2.7 SPECIAL CONDITIONS

2.7.1 ELIGIBILITY CRITERIA (COMPULSORY)

The tenderer must have done at least three similar type of work during the last three financial year and copy of the completion certificate to be attached.

2.7.2 ELIGIBILITY CRITERIA (FINANCIAL)

The intending tenderer must have completed the job worth of Rs.1.00 Crore turnover during the last three financial years.

2.8 SCHEDULE OF SUBMISSION OF REPORT:

a. Submission of Draft report : Fourth week from the date of award of work

b. Submission of Final report : Fifth week from the date of award of work

Note: The draft (01 copy) and final report (03 copies) should contain the following in PDF form, as well as the tenderer should furnish the soft copy of the reports so as to finalize the same in easy manner;

- The contour map shall be prepared preferably in A0 size with contours at 5m interval from the lowest bed level to M.W.L.
- Charts/drawings for the report all charts/ drawings shall be appropriately reduced for inclusion in the report.

2.9 FORCE MAJEURE

Neither the Contractor nor the Purchaser shall be considered in default in performance of its obligations hereunder if such performance is prevented or delayed for any causes beyond the reasonable control of the party affected, such as war, hostilities, revolution, riot, civil commotion, epidemic, major fires, explosions, floods, earthquakes or because of any law, order, proclamatory regulations or ordinance of Government or because of any act of God, provided notice in writing of such cause with necessary evidence that the obligation under the Contract is thereby affected or prevented or delayed, is given within 14 days from the happening of the event and in any case it is not possible to serve the notice within 14 days period, then within the shortest possible period without delay. In case the force majeure conditions prolong beyond a continuous period of 6 months, the Purchaser shall be entitled to decide the further course of action including revisions in the terms of Contract, if any.

- 2.9.1 As soon as the cause of Force Majeure has been removed, the party whose ability to perform its obligation has been affected shall notify the other party the actual delay occurred on account of such activities.
- 2.9.2 Although the time for completion of work shall be suitably extended (not exceeding the period during which the work was stopped on account of Force Majeure clause), such extension shall not result in any financial claim by the Contractor against the Purchaser or any account of such a delay for any other reason whatsoever.



2.10 TAXES

The price quoted shall be firm and shall be inclusive of all statutory levies and taxes including GST as applicable. Necessary income tax will be deducted at source on each bill as per the regulations in force. If the Institution is exempted from payment of income tax, the documentary evidence for the same has to be furnished.

2.11 JURISDICTION FOR LEGAL PROCEEDINGS

No suit or any proceedings in regard to any matter arising in any respect under this contract shall be instituted in a Court Save in the City Civil Court of Chennai or the Courts of Small Causes at Chennai. It is agreed that no other courts shall have jurisdiction to entertain any suit or proceedings even though part of the cause of action might arise within their jurisdiction. In case any part of cause of action arises within the jurisdiction of any of the courts in Tamil Nadu and not in the courts in the Chennai City, it is agreed to between the parties that such suits or proceedings shall be instituted in a court within Tamil Nadu and no other court outside Tamil Nadu shall have jurisdiction, even though any part of the cause of action might arise within the jurisdiction of such courts.

SECTION - III

TECHNICAL SPECIFICATION

1.1. SCOPE OF WORK

Mapping continuous and smooth topo-bathy of coastal and near shore environments has undergone rapid transitions from early, relatively low-resolution techniques, such as echo sounding in deeper waters and digital aerial photography in shallower waters, to modern advancements like high-density airborne laser bathymetry and multi-spectral satellite imagery that can now detect seafloor reflectance at depths ranging to 50–60 m. Cognitive recognition of features interpreted from aerial and satellite imagery, are directly applied in GIS-cartography programs to create comprehensive, informative, and interactive products. This new technology and its associated classification systems permit major advancements in the detailed mapping of topo-bathy that have never before been achieved for margins of regional seas.

In the current project new and innovative established techniques need to be employed for mapping the topography and bathymetry around Kamarajar port, Ennore. The following scope is conceptualized and will be engaged in the proposed project for the mapping.

- (3) High resolution Digitial Surface and Elevation model at scale of 1:5000 generated using Photogrammetry techniques and modern state of art technique
- (4) Smooth & continuous bathymetry and topography at scale of 1:5000 across waterline (surfzone, nearshore and offshore) using suitable platforms.
- (5) The vertical resolution that will be achieved through this technique need to be less than 0.1m for vertical with a spatial accuracy 0.05m.
- (6) In-situ measurement for water levels & currents using potential hybrid instrumentation platforms and survey systems.
- (7) To carryout water quality measurement of surface and along the water column using satellite remote sensing and insitu measurements.

In order to achieve the proposed scope of work multi-disciplinary expert team on software, hardware and custom instrumentation is essential to execute the tasks successfully. Also through this activity some of the outputs can be commercialized and it can be achieved easily through Industrial collaboration.
