The Quotations should be valid for sixty days from the due date and the period of delivery required, warranty terms etc. should also be clearly indicated. A minimum of one year warranty required. 3. Brochure detailing technical specifications and performance, list of industrial and educational 4. establishments where the items enquired have been supplied must be provided. Compliancy certificate is to be provided indicating conformity to the technical specifications. 5. If the item is under DGS&D Rate contract No. and the price must be mentioned. It may also please be indicated whether the supply can be made direct to us at the Rate contract price (Please note that 6. we are not Direct Demanding Officers). If so please send copy of the RC. Relevant literature pertaining to the items quoted with full specifications (and drawing, if any) should 7. be sent along with the Quotations, wherever applicable. Samples / machine/ equipment if called for should be submitted / demonstrated at free of charges, and collected back at the supplier's expenses. Packing and delivery charges must be clearly indicated. 8. The rate of sales / General Taxes and the percentage of such other taxes legally leviable and intended to be claimed should be distinctly shown along with the price quoted. Where this is not done, no claim for Sales / General Taxes will be admitted at any stage and on any ground whatsoever The taxes leviable should take into consideration that we are entitled to have concessional Sales Tax applicable to non Government Educational Institutions run with no profit motive for which a concession. Sales Tax Certificate will be issued at the time of final settlement of the bill. Goods should be supplied carriage paid and insured. 10. Goods shall not be supplied without an official supply order. 11.
