### Bidder Eligibility Criteria – I (Public Procurement – Preference to Make in India)

Only 'Class-I local suppliers' and 'Class-II local suppliers', as defined under DIPP, MoCI Order No. P-45021/2/2017-PP (BE-II) dated 16<sup>th</sup> September 2020 and other subsequent orders issued therein.

### Bidder Eligibility Criteria – II

- 1) Purchase order copies should be provided for at least 3 installations in India in reputed institutions (IITs, IISc, and Govt. laboratories) of the same model being quoted in the last 5 years. Contact person Name, Email Id., Phone no. & Institution Name should be provided of the quoted model for electron beam lithography tools & should be attached along with the technical specifications.
