## Clarifications given by IIT Madras

1. The class designation of concrete blocks mentioned in the schedule shall be M10 grade.
2. Detailed specification for the structural glazing is enclosed as Annexure 1 and the same shall be read in conjunction with the corresponding specification given in the BOQ.
3. IIT M will not supply water for construction and domestic requirements of labourers of the contractors.
4. No trees should be cut by contractor. If any tree obstructs the movement of vehicle or other construction activities the same should be informed to IIT Madras and necessary arrangements shall be made by IIT Madras to remove such obstacles.
5. All construction activities and labour movements should be restricted within the area earmarked for these purpose.
