- 2. The quotations duly sealed and super scribed on the envelope with the reference No. and due date, should be addressed to the undersigned so as to reach him on or before the due date stipulated above.
- **3.** The quotations should be valid for sixty days from the due date and the period of delivery required should also be clearly indicated.
- **4.** If the item is under DGS & D Rate Contract, Rate Contract Number and the price must be mentioned. It may also please be indicated whether the supply can be made direct to us at the rate contract price. If so, please send copy of the R.C. (Please note that we are not Direct Demanding Officers).
- **5.** Relevant literature pertaining to the items quoted with full specifications (and drawing, if any) should be sent along with the Quotations, wherever applicable. Samples if called for should be submitted free of charges and collected back at the supplier's expenses.
- **6. Local Firms:** Quotations should be for free delivery to this Institute. If quotations are for Ex-Godown, delivery charges should be indicated separately.
- **7. Firms outside Chennai:** Quotations should be for F.O.R Chennai. If F.O.R. Consigner stationer freight charges by passenger train/lorry transport must be indicated. If Ex-Godown, Packing, forwarding and freight charges must be indicated.
- **8.** The rates of Sales/General Taxes and the percentage of such other taxes legally leviable and intended to be claimed should be distinctly shown along with the price quoted. ## Required specifications:

- 1. This microinjector should be suitable for microinjection of the nematode C. elegans.
- 2. Should either have an in-built compressor, or connectable to an external gas cylinder.
- 3. Should include a controller unit that allows precise selection of pressure in the range of 0.0 to 80 psi in the injection mode.
- 4. The controller should have both manual and auto modes of pressure control.
- 5. The controller unit must have "purge" pressure selection, with at least 95psi pressure.
- 6. Should have both pulse and continuous injection modes.
- 7. Should include needle holder, tubing, and O-rings.
- 8. Should be operable using a foot-switch.
- 9. Foot switch for the controller unit should be included in the quote.
- 10. Power supply: 220-240 volts, 50 Hertz

Warranty: A minimum of two-year warranty on all parts.

Quantity: One microinjector + the necessary accessories to meet the above specifications
