On behalf of the Indian Institute of Technology Madras, offers are invited for the supply of "Caliper checker" conforming to the specifications given in (Annexure - III).

As per the Government of India Order, only "Class - I Local Suppliers" and "Class - II Local Suppliers" can participate in this tender.

Participation of Non local supplier may be subject to the limitation provided in para 4 (Exemption of Small Purchases) of DPIIT circular No.P-45021/2/2017-PP(BE-II) Dt 16.Sep.2020

Terms and Conditions of Limited Tender

- 1) Preparation of Bids: The Limited tenders should be submitted under Single bid system (i.e.) Technical-cum-Financial bid along with Vendor registration code. Vendor registration with IC & SR (IIT M) is mandatory for bidders to participate in tenders.

 - 2) Submission of the tender: The tender shall be sent to the below-mentioned addresses either by post or by courier ((duly sealed and super scribed on the envelope with the Vendor Email ID, Contact Number, tender reference No and due date & time)) so as to reach the following address before the due date and time specified in our Schedule:

- 3) Price: The price should be quoted only in INR net per unit (after breakup) and must include all packing, transit insurance and delivery charges to the Central Fabrication Facility (C.F.F.), IIT Madras
 - a. The offer/bid should be exclusive of taxes and duties. The percentage of tax & duties should be clearly indicated separately. IIT Madras is eligible for custom duty exemption certificate. Relevant certificate will be issued wherever necessary..

4) For the same tender, either the OEM or the authorized dealer/service provider can only quote. But both of them cannot quote separately for the same tender.

5) Terms of Delivery: -

Supplier will be fully responsible for the safe carriage of goods upto the **Central Fabrication Facility** (**C.F.F.**), IIT Madras or a named place, as per PO. The transit Insurance coverage will be in the scope of the supplier. The Installation/Commissioning should be completed as specified in our important conditions.

6) **Delivery Schedule:** - The tenderer should indicate clearly the time required for delivery of the item (subject to the approval of the Executive Committee of IIT-Madras). In case there is any deviation in the delivery schedule, liquidated damages clause will be enforced or penalty for the delayed supply period will be levied.

In the event of **delay or non-supply of materials/execution of Contract** beyond the date of delivery/completion of job, penalty will be levied @1% per week of delay subject to a max of 10% of the value of purchase order and if the delay is more than accepted time frame by IIT M, the PO would be cancelled and liquidated damages will be enforced.

- 7) Catalogue: Original catalogue (not any photocopy) of the quoted model duly signed must accompany the quotation in the Technical-cum-financial bid
- 8) Late offer: The offers received after the due date and time will not be considered
- **9) Payment**: No Advance payment will be made. However, 90% Payment against Delivery and 10% after installation are agreed to wherever the installation is involved.
- **10**) **Advance Payment:** No advance payment is generally admissible. In case a specific percentage of advance payment is required, the Vendor has to submit a Bank Guarantee from a Scheduled Commercial Bank of India equivalent to the amount of advance payment.
- 11) On-site Installation: The equipment or machinery has to be installed or commissioned by the successful bidder within the number of days (as prescribed by PI's) from the date of receipt of the item at the site of IIT Madras.
- **12) Warranty/Guarantee**: The offer should clearly specify the warranty or guarantee period for the machinery/equipment.

** Note: PO which involves installation, warranty/guarantee shall be applicable from the date of installation.

- 13) Validity: Validity of Quotation should be not less than 90 days from the due date of tender
- **14) Accept /Reject**: IIT Madras reserves the full right to accept / reject any tender at stage without assigning any reason.
- **15**) **Debarment from Bidding**: In case of breach of Terms & Conditions, Bidder may be suspended from being eligible for bidding in any contract with the IIT Madras up to 2 Years [as per Rule 151(iii) of GFR] from the date of Tender.

16) Disputes and Jurisdiction:

Settlement of Disputes: Any dispute, controversy or claim arising out of or in connection with this PO including any question regarding its existence, validity, breach or termination, shall in the first instance be attempted to be resolved amicably by both the Parties. If attempts for such amicable resolution fails or no decision is reached within 30 days whichever is earlier, then such disputes shall be settled by arbitration in accordance with the Arbitration and Conciliation Act, 1996. Unless the Parties agree on a sole arbitrator, within 30 days from the receipt of a written request by one Party from the other Party to so agree, the arbitral panel shall comprise of three arbitrators. In that event, the supplier will nominate one arbitrator and the Project Coordinator of IITM shall nominate on arbitrator. The Dean IC&SR will nominate the Presiding Arbitrator of the arbitral tribunal. The arbitration proceeding shall be carried out in English language. The cost of arbitration and fees of the arbitrator(s) shall be shared equally by the Parties. The seat of arbitration shall be at IC&SR IIT Madras, Chennai.

- a. **The Applicable Law:** The Purchase Order shall be construed, interpreted and governed by the Laws of India. Court at Chennai shall have exclusive jurisdiction subject to the arbitration clause.
- b. Any legal disputes arising out of any breach of contact pertaining to this tender shall be settled in the court of competent jurisdiction located within the city of Chennai in Tamil Nadu.
- 17) All Amendments, time extension, clarifications etc., will be uploaded in the website only and will not be published in newspapers. Bidders should regularly visit the above website to keep themselves updated. No extension in the bid due date/ time shall be considered on account of delay in receipt of any document by mail.
- **18) Risk Purchase Clause**: In the event of failure of supply of the item/equipment within the stipulated delivery schedule, the purchaser has all the right to purchase the item/equipment from other sources on the total risk of the supplier under risk purchase clause.
- **19) Unsolicited offers:** "This notice is being published **for information only** and is not an open invitation to quote in this limited tender. Participation in this tender is by invitation only and is limited to the selected registered suppliers. Unsolicited offers shall be ignored. However, suppliers who desire to participate in such tenders in future may apply for registration as per procedure." 20) Eligibility Criteria:

- > As per the Government of India Order, only "Class I Local Suppliers" and "Class II Local Suppliers" can participate in this tender.
- > Bidder should confirm their acceptance that they comply with the provisions with report to "Guidelines for eligibility of a bidder from a country which shares a land border with India as detailed at Annexure-IV. The bidder should submit Certificate for "Bidder from/ Not from Country sharing Land border with India & Registration of Bidder with Competent Authority" as per Order of DoE F.No.6/18/2019-PPD dated 23.07.2020 as mentioned.

21) Selection of Successful bidder and Award of Order.

The order will be awarded to the technically qualified bidder as per the condition in para 3A of DIPP, MoCI Order No. 45021/2/2017-pp (BE II) dated 16th September 2020 & P- 45021/102/2019-BE-II-Part(1) (E-50310) Dt.4th March 2021 and any subsequent modifications/Amendments, and latest orders if any.

- **22) Preference to "class I Local Suppliers":** In case of value of goods/works exceeding Rs 5 lakh (inclusive of taxes) preference will be given to "class I local suppliers" (subject to class -I local supplier's quoted price falling within the margin of purchase preference) as per public procurement (preference to Make in India) order 2017 .O.M No P- 45021/2/2017 pp(BE 11) dt 04/06/2020 subject to the conditions that the "Class I Local Supplier" should agree to supply goods / provide service at L1 rate and furnish a certificate with the bid document that the goods/service provided by them consists local content equal to or more than 50%...
- > 'Class I local supplier' means a supplier or service provider whose goods, services or works offered for procurement consists of local content equal to or more than 50% as defined under the above said order. Declaration to be provided as per Annexure-I per item/service/work.
- > 'Class II local supplier' means a supplier or service provider whose goods, services or works offered for procurement consists of local content equal to 20% but less than 50% as defined under the above said order Declaration to be provided as per Annexure-I per item/service/work.
- 'Margin of purchase preference': The margin of purchase preference shall be 20%. The Definition of the margin of purchase preference is defined in the Govt. of India Order No: P-45021/12/2017-PP(BE-II) Dt.4th June, 2020) Order 2017.
