# Tender for Laundry Services for Taramani Guest House and Bose Einstein Guest House <u>at IIT Madras</u>

- 1) Quotations are invited in two bid system to provide laundry services (washing, drying and pressing) for Taramani Guest House and Bose Einstein Guest House at IIT Madras and offers / bids should be submitted as Technical bid and Financial bid.
- 2) The Technical bid should consist of relevant documentary evidence for eligibility criteria, details and other documents to be submitted as per Annexure B.
- 3) The Financial bid should indicate item-wise price for each item and it should contain all commercial terms and conditions including taxes, payment terms, pricing terms etc. The financial bid should be submitted in the Annexure B. The Technical bid and Financial bid should be put in separate covers and sealed. <u>Both the sealed covers should be put in a single cover with superscription</u> "Laundry Services for Taramani Guest House and Bose Einstein Guest House at IIT Madras" on the left side and sealed.
- 4) The quotations should be valid for ninety days from the due date and should be clearly indicated.
- 5) The rate of GST and the percentage of such other taxes legally leviable and intended to be claimed should be distinctly shown along with the price quoted.
- 6) The work should not be initiated without an official work order.
- 7) Payment will be made on monthly basis after submission of bill.
- 8) Any damage or loss of items will be computed at 1% of the bill amount relating to the work and will be automatically deducted from monthly bill.
- 9) Service should be prompt and within prescribed time limit.
- 10) In case the laundry remains closed, alternative arrangements should be made for pickup and drop service.
- 11) The clothes should be collected from the Guest House premises on all week days and should be dropped back at the Guest House
- 12) Each Lot should be returned within 48 hours after Laundry service.
- 13) Appropriate detergents (eco-friendly), washing powder, fragrance, softener etc only to be used.
- 14) The bidder should give assurance for hygiene and cleanliness of clothes.

- 15) Washing and Ironing should be clean & neat. The clothes not washed properly viz. stains and wrinkles noticed will be sent back for re-washing without any additional charges.
- 16) Tenure of Contract: The period of contract will be for one year and the contractual period may be extended for another one year subject to the services are found satisfactory and the written consent from the successful bidder. In case of unsatisfactory services offered by the successful bidder, IIT Madras reserves the right to cancel the contract period with a one month prior notice.
- 17) The contract can be terminated by either party by giving one month's notice in advance.
- 18) All disputes or differences whatsoever arising between parties out of or relating to means and operation of this contract or the breach thereof shall be settled by the Committee constituted for this purpose.
- 19) The courts of Chennai will have exclusive Jurisdiction for any issue/dispute arising out of or in connection with the contract.
- 20) Late bids will be rejected. In addition to the above terms & conditions, Laundry services may be provided to Room Guests on demand.
- 21) The bidders shall visit the Taramani Guest House on 30.10.18 between 9.00 AM and to 4.00 PM.

# **ELIGIBILITY CRITERIA:**

- 1. The Bidder should have an established firm for a minimum period of 5 years located within Chennai city limits. Copies of Certificate of Incorporation/Registration Certificate of the firms to be enclosed.
- 2. Attested copy of deed of partnership, if the firm is a partnership concern and memorandum and Articles of Association duly certified in case of Company to be enclosed.
- 3. Photocopy of Shop & Establishment License /Permission of Fire Brigade Certificate to be enclosed..
- 4. Copy of registration under Contract Labour Act as well as certificate of registration of firm if so, with Registrar of Firms to be enclosed.
- 5. Copy of the PAN CARD of the firm to be enclosed.
- 6. The Bidder must **not be blacklisted/Suspended** for any service related dispute with any Organisation /Govt. Organisations/Semi Govt org/ Banks in India or outside India. **(Form A to be completed and enclosed)**
- 7. The bidder must have adequate experience in the execution of similar work in Govt. offices/ /PSUs / Autonomous Bodies and other reputed private organisations and Hotel Establishment. Necessary supporting documents like purchase orders, work completion certificate, payment certificate etc. for Laundry services in the range of Rs.8 to 10 lakhs per annum during last three years to this effect must be submitted along with the offer – (work completion certificate and bill to be enclosed and details in Form B)
- 8. The Bidder should have Annual Business Turnover of minimum 8 lakhs per annum for the last two Financial years i.e. 2016-17&2017-18. Form C (Copy of Audited Annual Accounts for the last two years to be submitted).
- 9. Brochure, original technical catalogue with detailed specification and picture of laundry services offered, if relevant to be submitted.
- 10. The Bidder should have submitted / filed Income Tax Return for last two years. **Form C.** (Copy of filed Acknowledgments to be submitted.)
- 11. Bidder's profile to be submitted in Form D Late collection of clothing items from the Guest House premises and late delivery will entail penalty of 1% of the cost of the lot to be picked up/ to be delivered as the case may be.

- 13. List of material (Detergents, fragrance, softener, stain remover etc. used) to be furnished.
