- 2. The quotations duly sealed and super scribed on the envelope with the reference No. and due date, should be addressed to the undersigned so as to reach him on or before the due date stipulated above.
- **3.** The quotations should be valid for sixty days from the due date and the period of delivery required should also be clearly indicated.
- **4.** If the item is under DGS & D Rate Contract, Rate Contract Number and the price must be mentioned. It may also please be indicated whether the supply can be made direct to us at the rate contract price. If so, please send copy of the R.C. (Please note that we are not Direct Demanding Officers).
- **5.** Relevant literature pertaining to the items quoted with full specifications (and drawing, if any) should be sent along with the Quotations, wherever applicable. Samples if called for should be submitted free of charges and collected back at the supplier's expenses.
- **6. Local Firms:** Quotations should be for free delivery to this Institute. If quotations are for Ex-Godown, delivery charges should be indicated separately.
- **7. Firms outside Chennai:** Quotations should be for F.O.R Chennai. If F.O.R. Consigner stationer freight charges by passenger train/lorry transport must be indicated. If Ex-Godown, Packing, forwarding and freight charges must be indicated.
- 8. The rates of Sales/General Taxes and the percentage of such other taxes legally leviable and intended to be claimed should be distinctly shown along with the price quoted. Instrument should have laser autoalignment feature to ensure consistent performance.

System should have features for automated identification and matching of the optical configuration.

System should accommodate wide range of input devices in the manual loading position including

5,15 & 50 ml conical tubes & 0.5ml / 1.5ml microcentrifuge tubes.

System should have upgradability option of built in sample loader platform which can accommodate

minimum 30 tubes and vortex option should be there.

Software should have pre-defined assay menu for one-click launch. The system should also allow

analysis of data parallel to sample acquisition.

The system apart from offering low, medium & high flow rates, should also offer high sensitive

mode, which can result in higher fluorescence signal resolution which is required for applications

where there is need to look at dim stained populations.

System should have provision for future upgradation.

Company should have proven capability demonstrated in the past in after-sale-service and

application support in the field of flowcytometry instrumentation in india.
