- 1. Approximate maximum quantity required per day : 500kL
- 2. Quality of water shall meet drinking water parameters as per relevant Indian Standard.
- 3. The required quantity shall be supplied within 24 hours from the actual supply of placing order.
- 4. Rate shall be quoted in Rupees per kilo liter.
- 5. The rate shall include all applicable taxes, royalties, loading and unloading charges etc.
- 6. The rate shall be valid for a period of 4 months.

SPECIAL CONDITIONS

- 1. The quality of water to be supplied shall confirm the drinking water parameters.
- 2. The contractor shall obtain necessary entry pass/seal in the delivery challan from the IN gate security at IIT Madras
- 3. Adequate safety measures should be taken care while driving the vehicle inside IITM Campus.
- 4. The work shall be awarded to the lowest bidder.
- 5. The water shall be supplied to underground sumps at various locations of IIT Madras.
