The bidder/OEM should have supplied at least 5 similar items to IITs, NITs, IISERs, CSIR Labs or other Govt. organizations in the last 5 years, PO copies or installation certificates along with contact details of end user need to be submitted as the proof of supply. IIT Madras reserves its right to verify the claims submitted by the bidder and the feedback from the previous customers will be part of technical evaluation.

III. Technical Specification For Computer Controlled gas Mixing System

The system should comprises of Mass flow controllers, power supply, Communication cables, Software and hardware for precise gas mix ratio flow control System.

Application and description:

Mass-flow controllers based Gas Mixing System and supplying system. Shall be able to simultaneously mix a maximum of 8 different gases and to produce desired concentration of the mixed gas output. By using the suitable gas mixing Software from the computer control system. The software should maintain the exact proportion defined by constantly comparing MFC data with the mix equations. The system should be fully automatic and should be expandable and upgradable to resize for different flow and concentration Ranges for future requirements. Currently we need two manifolds which can mix two fuels and nitrogen, and deliver as a mixture at required flow rate and composition. O₂/air flow will be separate and not mixed with fuels. It must be possible to set the flow conditions from a computer(computer not in scope of tender, but interface/software for it is).
