- 5. Relevant literature pertaining to the items quoted with full specifications (and drawing, if any) should be sent along with the quotations, wherever applicable. Samples if called for should be submitted free of charges and collected back at the supplier's expenses.
- 6. **Local Firms:** Quotations should be for free delivery to this Institute. If quotations are for Ex-Godown, delivery charges should be indicated separately.
- 7. **Firms outside Chennai:** Quotations should be for F.O.R Chennai. If F.O.R. Consigner stationer freight charges by passenger train/lorry transport must be indicated. If ExGodown, Packing, forwarding and freight charges must be indicated.
- 8. The rates of Sales/General Taxes and the percentage of such other taxes legally leviable and intended to be claimed should be distinctly shown along with the price quoted. Where this is not done, no claim for Sales/General Taxes will be admitted at any stage and on any ground whatsoever.
