The price bid should be submitted in excel format (BoQ) as per the proforma (Annexure C) uploaded in the e-Tender web site. The Quoted price should be for supply and installation of the item and inclusive of all cost and statutory levies at IIT Madras.

#### 5) Price: a) The price should be quoted only in INR net per unit (after breakup) and must include all packing, transit insurance and delivery charges to the ent of **Department of Mechanical** Engineering. b) The rate quoted shall be all inclusive of all taxes and no extra payment will be made other than statutory revisions as per the terms and conditions stipulated in this contract document. #### 15) Risk Purchase Clause

In the event of failure of supply of the item/equipment within the stipulated delivery schedule, the purchaser has all the right to purchase the item/equipment from other sources on the total risk of the supplier under risk purchase clause.

#### 16) Payment:

- (i) No Advance payment will be made. However, 90% Payment against Delivery and 10% after installation are agreed to wherever the installation is involved.
- (ii) Advance Payment: No advance payment is generally admissible. In case a specific percentage of advance payment is required, the Vendor has to submit a Bank Guarantee from a scheduled commercial bank in India equivalent to the amount of advance payment.

#### 17) On-site Installation:

The equipment/item or Machinery has to be installed or commissioned by the successful bidder within the number of days (as prescribed by PI) from the date of receipt of the item at the site of IIT Madras.

#### 18) Warranty/Guarantee:

The offer should clearly specify the warranty or guarantee period for the machinery/equipment. Any extended warranty offered for the same has to be mentioned separately (For more details please refer our Technical Specifications).

\*\* Note: PO which involves installation, warranty/guarantee shall be applicable from date of installation.

#### 19) Acceptance and Rejection:

Failure to comply with any of the instructions stated in this document or offering unsatisfactory explanations for non-compliance will likely to lead to rejection of offers.

I.I.T. Madras has the right to accept the whole or any part of the Tender or portion of the quantity offered or reject it in full without assigning any reason.

#### **20)** Debarment from Bidding:

In case of breach of Terms & Conditions, Bidder may be suspended from being eligible for bidding in any contract with the IIT Madras up to 2 Years [as per Rule 151(iii) of GFR] from the date of Tender.

#### 21) Disputes and Jurisdiction:

Settlement of Disputes: Any dispute, controversy or claim arising out of or in connection with this PO including any question regarding its existence, validity, breach or termination, shall in the first instance be attempted to be resolved amicably by both the Parties. If attempts for such amicable resolution fails or no decision is reached within 30 days whichever is earlier, then such disputes shall be settled by arbitration in accordance with the Arbitration and Conciliation Act, 1996. Unless the Parties agree on a sole arbitrator, within 30 days from the receipt of a written request by one Party from the other Party to so agree, the arbitral panel shall comprise of three arbitrators. In that event, the supplier will nominate one arbitrator and the Project Coordinator of IITM shall nominate on arbitrator. The Dean IC&SR will nominate the Presiding Arbitrator of the arbitral tribunal. The arbitration proceeding shall be carried out in English language. The cost of arbitration and fees of the arbitrator(s) shall be shared equally by the Parties. The seat of arbitration shall be at IC&SR IIT Madras, Chennai.

a. **The Applicable Law:** The Purchase Order shall be construed, interpreted and governed by the Laws of India. Court at Chennai shall have exclusive jurisdiction subject to the arbitration clause.

- b. Any legal disputes arising out of any breach of contact pertaining to this tender shall be settled in the court of competent jurisdiction located within the city of Chennai in Tamil Nadu.
- **Force Majeure:** The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

## Eligibility Criteria:

- > As per the Government of India Order, only "Class I Local Suppliers" and "Class II Local Suppliers" can participate in this tender.
- Bidder should confirm their acceptance that they comply with the provisions with report to "Guidelines for eligibility of a bidder from a country which shares a land border with India as detailed at Annexure-E. The bidder should submit Certificate for "Bidder from/Not from Country sharing Land border with India & Registration of Bidder with Competent Authority" as per Order of DoE F.No.6/18/2019-PPD dated 23.07.2020 as mentioned.

  - > 'Class I local supplier' means a supplier or service provider whose goods, services or works offered for procurement consists of local content equal to or more than 50% as defined under the above said order. Declaration to be provided as per Annexure-D per item/service/work.
  - > 'Class II local supplier' means a supplier or service provider whose goods, services or works offered for procurement consists of local content equal to 20% but less than 50% as defined under the above said order. Declaration to be provided as per Annexure-D per item/service/work.
  - ➢ 'Margin of purchase preference': The margin of purchase preference shall be 20%. # Bidder Eligibility Criteria and Technical Specification for "Custom Specific Air And Argon Gas Chilling System With Controlled Environment"

#### Bidder Eligibility Criteria – I (Public Procurement – Preference to Make in India)

Only 'Class-I local suppliers' and 'Class-II local suppliers', as defined under DIPP, MoCI Order No. P-45021/2/2017-PP (BE-II) dated 16<sup>th</sup> September 2020 and other subsequent orders issued therein.

#### Bidder Eligibility Criteria - II


- 1. The bidder/OEM should have supplied or serviced any kind of such chilling unit to at least 1 similar items to IITs, IISc, NITs, IISERs, CSIR Labs or other Govt. R&D organizations in the last 5 years, PO copies or installation certificates along with contact details of end user need to be submitted as the proof of supply. IIT Madras reserves its right to verify the claims submitted by the bidder and the feedback from the previous customers will be part of technical evaluation.
- 2. The supplier should be equipped with well-trained engineers to offer post warranty maintenance and service support.

# III. Technical Specification For "Custom Specific Air And Argon Gas Chilling System With Controlled Environment"

#### 1. Equipment requirement

The compact air and argon chilling system must have the following requirement:

- 1.A single integrated and compact unit of gas chilling and dehumidifying system, which should be able to cool and dehumidify the Air and Argon gas separately at different instants of time, of which the temperature range should be from  $2^{\circ}$ C (Two degrees Celsius) to  $10^{\circ}$ C (Ten degrees Celsius) at the sites where the gas will be purged.
- 2. The outlet gas from the above system should be supplied to two different machine setups at different instants of time, for which control valve should be there for each machine, which is to be located in two different directions, and to be assembled in following ways:
- 2.1. Machine 1 should have two nozzles on either side, which are A and B, respectively, as shown in the following figure, which should purge cooled and dehumidified air or argon gas continuously focusing at the center. The purged gas should cover the aimed area and cool the metal, which will have a maximum width of 5 cm of the continuous-length strip. There should be a provision for both nozzles to be tilted to at least 60° in both directions from the horizontal position.
- 2.2. Machine 2 should have two pairs of nozzles on either side, which are A, B, C and D, respectively, as shown in the following figure, which should purge cooled and dehumidified air or argon gas continuously focusing at the center. The purged gas should cover the aimed area and cool the metal, which will have a maximum width of 10 cm of the continuous-length strip. There should be a provision for all four nozzles to be tilted to at least 60° in both directions from the horizontal position.

## 3. The chiller system with receiver should have a provision to switch from air to Argon gas and vice versa, as inlet supply with a different time instance. Conditions for supplying the gasses are as following ways:

- 3.1 From the air supply system, air should be supplied through an air compressor which should have the following specifications:
- 3.1.1. Compressing capacity should be at least 8 kg/cm<sup>2</sup>.
- 3.1.2. The discharged volume of air should be more than 25 cfm.
- 3.1.3. The compressor should be screw-type.
- 3.1.4. The compressor should produce sound of less than 70 dB.
- 3.1.5. There should be a belt-driving system.
- 3.1.6. Compressor should have more than 7 HP motor.
- 3.1.7. The compressed air should be entirely de-humified before entering the receiver.
- 3.2. The Argon supply system should supply the Argon gas, which is to be drawn from an Argon gas cylinder, which should have a provision to connect and disconnect at the time of refilling.
- 4. In order to make the above system, it should be as compact as possible. The area covered at the base should be less than 3.5 meter square.
- 5. There should be absolutely no humidity in the purged gas.

#### 6. There should be the following sensors at least:

- 6.1. Compressor auto-derive sensor for maintaining pressure.
- 6.2. Temperature sensor to check ambient temperature and the temperature at the purging area in both machines separately.
- 6.3. Flowmeter for air and argon gas supply.
- 6.4. Humidity sensors.

#### 7. Control Panel:

- 7.1 The control panel should be Human Machine Interface based and should be user-friendly.
- 7.2 Capable of measuring at least the following with proper accuracy: (i) ambient temperature (ii) purged gas temperature in both machines separately, (iii) Compressor pressure, (iv) Argon cylinder pressure (v) Flow rate of gases in each machine and (vi) humidity sensor.

- 7.3 Temperatures of the purged gas on the machines must be controlled from  $2^{\circ}$ C (the lower limit of the temperature of purged gas can be less than  $2^{\circ}$ C) to  $10^{\circ}$ C with great control accuracy of +/- 0.5  $^{\circ}$ C.
- 7.4 A proper digital controller must indicate power, voltage and current.
- 7.5 Necessary HRC fuse must be provided.

#### 8. The supplier must supply the following essential accessories for the maintenance of the said equipment:

- Tool Box: 1
- Lubricant oil.
- Other necessary consumables required for running the machine.
