As per the tender, the Large Purchase Committee has evaluated the Pre-qualification Eligibility Criteria-I and found that M/s. Inspire Office Systems, Chennai has not followed the two bid system i.e. submitted price bid in the technical bid and M/s. Leo Steel Industries, Coimbatore was suspended by the GeM. Hence both the firms M/s. Inspire Office Systems and M/s. Leo Steel Industries were not considered for further evaluation.
