Bidder Eligibility Criteria – I (Public Procurement – Preference to Make in India)

Only 'Class-I local suppliers' and 'Class-II local suppliers', as defined under DIPP, MoCI Order No. P-45021/2/2017-PP (BE-II) dated 16th September 2020 and other subsequent orders issued therein.

Bidder Eligibility Criteria – II

- The Bidder shall be a specialized company in the environmental engineering and climate change projects. Any Consortium of companies (not more than TWO (2) companies) with divided experience in the proposed line of work, is also eligible to submit the Bid.
- The bidding company or Minimum ONE company in the Consortium shall be a registered company in India.
- The bidding company or at least one member of the Consortium shall have experience in Industrial Emission Capture Systems.
- The bidding company or at least one member must have experience in Construction, Erection and Commissioning of Air Pollution Control Devices in Red Category Industries.
- The bidding company or at least one member of the Consortium must have exposure or experience in securing regulatory compliance certificates for Industrial activities in parts or full.
- The bidding company or the consortium shall provide evidence to prove capacity to secure resources and mobilization of materials to commence, construct and complete the proposed works within NINETY (90) days after receiving the official work order along with payment as per terms.
- The bidding company or at least one member of the consortium shall provide proof of annual turnover for more than 50% of the proposed cost of the project. This certificate must be issued by a practicing Chartered Accountant certifying the annual turnover as per prescribed format .
- In case of a Consortium, a MoU signed between both the parties with details of roles and duties specific to this specific project.
- The service center should be within Chennai, Tamilnadu. Proof of facility registration, location & contact details to be provided along with technical bid.
