Design, fabrication and integration of Waterjet Testing unit:

The specifications are given below:

GENERAL DESCRIPTION:

The TEST RIG is a floating vessel with dimensions between 8 and 9m length, 3.5m beam, 1.5m depth. The bow shape design (flat sloping plate and not the usual streamlined bow) emulates the flow in the FICV and is therefore necessary. The augmented drag replicates the dynamics realistically. The TEST RIG ends with a catamaran shape at the rear end for the last 1.5 to 2m. Rudder is not required. The TEST RIG has a water-cooled marine diesel engine (ALM or equivalent) of approximate 75 kW capacity when running at not less than 2000 rpm. The TEST RIG has a stern tube with shaft ending outside in a flange. There is no propeller. The flange at the end of the shaft mates with the water jet unit. A small generator unit of about 2kVA capacity serves as a power source for immediate minimal lighting, and for running the measurement system (thrust torque transducer, data acquisition system).

HULL:

The material for construction is fiberglass. The scantlings follow equivalent Classification Society Rules, though the vessel is not under Class. The hull should have a forward collision bulkhead, a simple cabin with weather protection for steering as well as providing the base for data acquisition, engine room bulkhead and main deck. Protective railing on the main deck provides safety. Bollards for mooring and a tow post for measuring bollard pull thrust, rubber fender/tires for protection during berthing are required. The main deck strengthened with beams and stiffeners must take the nominal deck load. The hull design is only for calm water condition with maximum 30 cm high waves. The TEST RIG being a special platform does not require Class certification. The draft of the vessel is approximately 0,6m and ballasting may be required to achieve this at even keel. The total number of people on board will be 5.

Hull form should conform to the concept drawing enclosed herewith. Preference is for a manufacturer with proven hull form and possessing the necessary DIE (mould) for ready manufacturing. Experience in the manufacture of similar size vessels with outfit is also a requisite.

OUTSOURCED ITEMS SUPPLIED BY IITM AND FOR INTEGRATION BY THE BUILDER:

- i) Marine diesel engine of ~75 kW capacity (ALM series or equivalent) including control panel on deck, remote starting system, cooling system.
- ii) Thrust and torque transducers for integration with the water jet system for input and output power measurement.
- iii) 2kVA generator system and simple navigational aids viz., depth sounder, Speed logger.

The bidder should confirm availability of suitable mould (die) for manufacture of the unit. The quote should include the cost for

- (a) supply of the hull as per the specifications in the drawing and
- (b) integration cost for the above supplied items which will be.

DELIVERY: The complete vessel including integration of the above items must be delivered at Kochi at a waterfront. (to be specified later).

NOTE: The design and manufacture of the floating test rig is of a specialized nature and does not conform to routine boat building. The integration of various items in the hull including the semi-catamaran aft construction, mounting the water jet unit to the outer shaft, and integrating the instrumentation in liaison with the project team are special requirements in this project. Therefore, bidder must present availability of aforementioned requisites and willingness to complete the above requirements.




Fig.1 Perspective view of the hull form, flat forward and semi-catamaran aft, for test water jet unit.




Fig.2 Bottom view with skeg.







Fig.3 The water jet unit placed at the aft between the semi catamaran hulls









Fig.8 Stern tube arrangement (schematic, dimensions may differ)
