III. Technical Specification for ULTRASOUND SIMULATION SYSTEM

General

High end high fidelity ultrasound Training Module should have the outside look of a real ultrasound machine, using mock transducers, anatomically correct mannequins with internal sensors which correspond with the aforementioned ultrasound Training Module.

The ultrasound panel should be International replication of GE-style/Equivalent leading ultrasound one which will contain top flood light (above the operation panel) to allow working in simulated ultrasound environment.

Functions within the panel should have: trackball, measurement function, keyboard, annotation button, and freeze and store buttons.

System should have internal speakers to allow hearing voice prompt which will be a part of the offered cases.

Content wise the Training Module to have real patient cases alongside patient data per case.

The system shall allow the user to choose the relevant area to work on (for instance Abdomen, Vascular etc) with a simple change of media.
